Replace eleven windows in the newer part of the house, with functioning, traditional hardwood sash windows. These would be fitted with traditional pulleys, weights + fasteners. The windows would be traditional slender (23mm) lamb's tongue profile, taking 12mm slimline glazing, with narrow meeting rails, slender framing, all in hardwood + glazing would be face painted with 'Hodgson' heritage putty.

Replace the front door + frame for a more traditional hardwood door that is weather proof.

Re-install external wooden window shutters, where they have been removed.
