Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Southern Water are proposing a new bypass off-take and barage within a stream south of Nargate Street, Littlebourne, Canterbury. The works will take place in close proximity to an existing crack willow tree.

The tree should be removed for reasons of sound arboricultural management. There is a history of failed willows within the same line of trees south of Nargate Street. The tree is in poor condition with several large cavities on all sides of the stem which increases the likelihood of collapse.

The cost of special construction measures would be disproportionate to the value of the tree considering its limited life expectancy. Proposed works should take place after the tree has been removed as further damage to the rooting environment may increase the likelihood of failure.

Since the tree is at the end of the tree line the additional exposure caused to nearby trees will be minimal and it is not anticipated that pruning or pollarding of further trees within the tree line will be necessary as a result of the removal of T1.

The tree is within Wickambreaux Conservation Area.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
