Proposed construction of a first-floor extension above the existing footprint of the bungalow. The proposed extension would involve increasing the roof pitch and increasing the ridge height of the dwelling by approximately 1.6 metres to a total of approximately 5.5 metres above ground-level. The development would also involve the installation of new pvc windows within the north eastern and south-western elevations of the dwelling, and roof lights within the north western and south-eastern roof planes. The proposed extension would provide two new bedrooms and a bathroom and a small storage room on the first-floor of the dwelling. The extension would be finished externally with Marley grey roof tiles and red brickwork, both the match the existing.
