Willow #1 - Regularly drops large branches on the drive, causing issues to moving cars and potential damage from falling branches to parked cars. Creates danger/damage to passing vehicle/pedestrians from low hanging branches. Also this large tree now blocks light to Jubilee Cottage & Hunters Cottage. Propose removing Willow 1 and re-plant with an Acer. Rowan #2 - crown thinning by 30%

Cherry #3 - crown thinning by 30%
