T1) Small oak tree - one metre reduction from south side which is overhanging the road to allow clearance for heavy goods vehicles -see picture number 1

T2) spruce tree- crown lift on south side 3.5 metres from ground level to allow access for heavy good vehicles -see picture 2

T83) horse chestnut tree - crown lift of 3.5 metres from ground level, to allow access for heavy goods vehicles, See picture 3

T23/T24/T37

Yew tree

3.5 metre crown lift from ground Level over old hall drive so work vehicles can pass by without hitting them - please see picture 4

T22

Norway maple

Overhang over old hall drive to be removed and also to be removed out of the cables please see picture 5

T21) multi stem sycamore

Crown lift of 3.5 metres from ground level and removal of conflicting stem, to free up bt cable and allow neighbouring stem to grow unimpeded - see picture 6, 7 and 8

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
