Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
T1 – Weeping willow is to be re-pollarded to previously pollarded point at 3.5 meters high. Removing approximately 3-4 meters of re-growth.
T2 - Conifer, all one sided is to be removed to ground level.
T3 – Apple tree, with crown die back throughout the upper canopy is to be removed to ground level.
T4 – Spruce is to be removed to ground level.
T5 – Conifer is at the end of the hedge that is to be replaced is under the low voltage power line, this tree is to be removed to ground level.
H1 – Privet hedge, is to be removed to ground, and a native hedge is to be replanted in its place.
T6 – Laburnum nearest the house is to be removed to ground level.
T7 – Hazel up against the shed is to be removed to ground level.
G1 – Group of thorns are to be removed to ground level.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
