Please accept this submission in accordance with the abovementioned regulations.

This submission confirms the operators' intent to use permitted development rights to install electronic communications apparatus at the subject site and hereby gives the Local Planning Authority 28days notice in advance of the works taking place. For the avoidance of doubt, this submission does not constitute and application for planning consent and no fee is required.

## **Technical Justification**

As part of EE Ltd's ("EE") ongoing commitment of keeping Local Planning Authorities informed of electronic communications development in their area we hereby confirm the operator's intention to install telecommunications apparatus at the above location.

The main purpose of the works is to provide improved network coverage and capacity in the area around the subject site.

## The Proposed Works

A description of the proposed works and following electronic communications apparatus is outlined below:

Removal and replacement of 1No. cabinet and all ancillary development

The development will be located at the subject address with the site layout as marked on the attached drawings. Please note that any works annotated in blue will be undertaken as part of a separate project with separate planning being submitted where necessary. All elements of this proposal have been limited in terms of size and amount to ensure the delivery of public benefit via the efficient and uptodate mobile services it will provide.

The proposed works constitute permitted development as identified in Class A, Part 16, of Schedule 2 of the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended).
