T1 - Lime tree (Tilia cordata) - Height 13m - crown spread 10m- reduce in height and spread by 2-4m. The tree works are for reasonable arboricultural management . Also the client has requested the works, to limit the amount of light the tree blocks from his garden. There are also some defects (weak unions and potential decay pockets, observed from the ground), within the crown of the tree that will be inspected, during the pruning work.
