G1- Group of Leylandii varying in diameters from 0.4m-0.7m, height of 7m, and canopy spread of 7m in total with all 4 trees together.  Permission requested as to remove these 4 Leylandii, as they are beginning to encroach and detriment a specimen Japanese Zelkova, they serve no aesthetic amenity, and are unsightly in the location, plus potential future failure could pose a threat due to expose to prevailing winds from across neighbouring fields
