- To remove existing open fire and surround/hearth (fireplace 1 on plan), and carry out necessary works to restore fireplace to original size, allowing space for a woodburner to be installed. Flagstone hearth to be fitted and any plastering/making good to match existing. All fireplace works to be carried out by a Hetas certified engineer.
- To remove partition wall between lobby area and dining room and to remove WC room (partition walls between lobby and kitchen room) to create space for kitchen/family room. All making good to be done using multi-finish plaster to match existing and wooden dado rail to be fitted where needed to keep continuity. WC to be re-located to understairs cupboard area, making use of existing space.
