Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
Large group of sycamores approximately 25m in height. To reduce the crown by one third and raise the crown by removing overhanging lower branches to 5 metres.
2. Remove 2 low hanging branches of ash tree to improve overall shape and to avoid branches touching shrubs and fence beneath.
3. Raise the crown of overhanging branches of walnut tree to enable light onto flower bed beneath.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
