## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 - Cherry tree. This tree was subject of a previous application DM/20/02588/TCA where one of main large limbs was removed due to disease. Unfortunately the decay had already affected the top of the main stem which could not be removed. The tree has continued to decline and this year had very poor show of leaf bud and has now has no leaf cover at all. T1 forms part of a row of trees with other Cherry trees G1 along the verge through the village. Request for T1 to be felled and the owner intends to plant two flowering Cherry trees on the verge.

T2 - Maple, some branches of this tree overhang the neighbours property, it is requested to prune selected branches back to a the boundary line to allow better clearance for the neighbours camper van to access the driveway.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
