Details of the pre-application advice received
Conversion and extension to existing stables to form annex for elderly family members.  Based on the information that you have supplied, it is my informal opinion that this proposal could be supported by officers and gain a recommendation of approval.  The extension appears appropriately designed and has been kept to a modest, and what seems to be minimum, size, which are important factors contributing to that view. You should also ensure that the annex shares its services – water, electric, sewage etc – with the main dwelling on site, including sharing the meters for those services, to provide a functional tie between the two, since the unit would contain its own kitchen facilities and so be capable of independent use. The sharing of such services should be confirmed in the covering statement submitted with any formal application.  There do not appear to be any neighbouring amenity issues in view of the distances involved, and adequate parking provision exists within the curtilage.
