## Description of Proposed Works

Please describe the proposed works

Due to settling/subsidence the central chimney had gradually shifted causing significant cracking to appear, particularly on the east facing chimney breast. (large enough to put your hand inside). The application is for the emergency work carried out to rebuild a section of the east chimney wall.

In accordance with the structural engineers recommendations the wall has been rebuilt without the bowing that appeared in the original pictures. The bow in the wall was deemed structurally unsound and thus its been rebuilt straight to improve structural strength and tie in the mid feathers wall that was floating and unsupported. To reduce the weight on the screw piles/foundations (see the previous application) and to help reduce the risk of future subsidence the arched/curved structure (that may have been a previous structural alteration to support the bowed wall) has been removed.

As many salvageable bricks were reused in the new wall as possible and we sought additional bricks via taking a 5-6 bricks that had come out of the chimney wall to the reclamation yard in a matching exercise (as best we could, given the emergency/timeframes).
