T1 Cherry Reduce all aspects of crown by approx 2-3m to create a tight and tidy shape. Remove deadwood, crossing branches and thin by 10%.
T2-T3 Hornbeam Thin crowns by approx 20-25% to allow more airflow and light into the garden.
