1984/19075/TPO (G1) AMIX - Note due to this property been empty for 30 years the condition of the garden was extremely poor prior to us purchasing this property and its very much over grown.

Removal of x1 sycamore due to rotten trunk found by competent person, rot its at the base and quite bad with tree leaning towards another property

To reduce and shape 5 yew tress in middle of the garden by 2m

To reduce x3 yew and x3 holly by 5m and shrink sides by 3m and crown lift the bottoms to 3m height. Note x1 Holly is suffering with decay at the base and is leaning towards the care home.

X5 yew tress located middle of garden require maintenance, shrinkage by 2m all round maximum and a general clean up. G1 AMIX

X1 Sycamore located at bottom of garden requires full removal due to decay at the base of the tree and is leaning towards another property. G1 AMIX

x3 holly / x3 yew located together at other end of garden require 10m reduce from tops and 3m reduce from sides maximum only on area that have grown out to much. G1 AMIX

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
