## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

It is a cherry tree as identified by Robert Seddon of RS Garden Services who will be carrying out the works if granted permission. It is identified on the plans by a red dot and the 'cherry tree' label. The proposed works are to fell the tree completely to stop it's roots continuing to grow under the adjoining wall between 39 and 37 Ashley Hill. As shown in the surveyor's observations the wall is in a considerable state of disrepair and needs to be rebuilt. We are not proposing to plant replacement trees due to the adjacent T1 Copper Beech nearby this cherry tree and the closeness of walls and property to the garden area.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - o sketch in buildings, including adjoining properties
  - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
