Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Position of all three trees is within the school boundary, at the front of the school, facing on to Abbey Road.

1. Removal of a dead tree. Species unknown, due to having no leaves.

This tree presents a hazard to the road and school as it is dead and liable to fall in strong winds.

2. Removal of a very overgrown elderflower bush/ tree.

It is difficult to determine whether this is an overgrown shrub or actual tree due to the size that it has now grown to. Removal of this plant is crucial as it is blocking light into the school.

3. Removal of an established sycamore tree.

This tree is preventing light from entering the school building. At any point of the day, the classroom that it is situated in front of, has to have their lights on- a major concern given the cost of lighting to our school. Furthermore, this tree has become very overgrown and I am concerned about any damage that may be caused by the roots on the school building which sits in the heart of a conservation area. If it is not possible to remove this tree, please can I request permission to have it reduced by at least 50%?

Please note that there is evidence of previous tree removal along the same site- large tree stumps identified. Permission has previously been granted to reduce a silver birch tree by at least 50% in August 2017.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
