Silver Birch Reduction: 3m to 5m reduction after movement in gales. T5 Sycamore: Removal T4 T1 T2 (t1 and t2 are self seeded offshoots) Offshoot Beech x1 removal. T3. (please note this is not the senior beech with TPO's on this is a self seeded offshoots 50ft away from TPOs)

All assessed by Oliver Hussar Arborist - He recommended reduction of birch after watching it move during storms.
