Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

- 1. Yew tree front of house remove as have not been maintained and now restricting other plants and trees at front of house.
- 2. Ash tree rear of house (right hand side) crown reduction 2m spread and 1m height (periodic maintenance).

3. Yew tree - rear of house (right hand side) - remove as no amenity value and restricting other growth.

4. Poplar tree - rear of house (left hand side) - fell as has aggressive growth and is inappropriate for the size of garden and proximity of neighbouring properties.

5. Apple tree - rear of house (left hand side) - crown reduction 1m spread and 0.5m height (periodic maintenance).

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
