T1 Horse Chestnut - The southern aspect of the tree should be reduced by approximately 2m to lessen the overall weight and probability of failure into the road. Crown lift to achieve a clearance of approximately 2.5 meters from ground level to reduce the amount of shading in the garden.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
