## Please identify the tree(s) and provide a full and clear specification of the works you want to carry out Ornamental Species, Yew & Sycamore Front Garden Ornamental Tree (IN CONSERVATION AREA) This tree is an unknown species is approximately 3 metres tall with a 2-metre canopy spread and a trunk diameter of approximately 200mm. The tree is in average condition, but has a severe lean and is propped up on the fence which encroaches on the community centre. Given the heavy tree cover in this area, this tree offers minimal value. Yew Tree - T2 (ON TPO MAP) AND IN CONSERVATION AREA This tree is approximately 8 metres tall with a 4-metre canopy spread and a trunk diameter of approximately 500mm. This tree is roadside and in good visual condition, it offers visual value to the area. However, lower limbs are encroaching on the road. This tree is approximately 9 metres tall with a 3-metre canopy spread and a trunk diameter of approximately 450mm. This tree is roadside and in good visual condition, it offers visual value to the area. However, lower limbs are encroaching on the road.

  - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
