Good Morning Denise,

Thank you for your email.

Upon consulting with a duty planning officer they have given the following advice:

'The land described as paddocks by the enquirer is currently deemed to be agricultural, and would therefore require a full planning application to change use to equestrian use. It is advisable that should an application come forward for the proposed change of use from agricultural land to equine land that the application should combine details of any proposed subdivision of the land with fencing and stables (static or mobile) and any provision of access, hard/soft landscaping alterations or external lighting is advisable to outline.'
