T1 Lime - To crown lift over adjacent buildings to give a 3 metre clearance from property. To reduce weight and increase light levels via a crown thin removing 20% of the foliar area, target pruning cuts of up to 75mm.

T2 Elm - To dismantle to ground level. The tree is in decline with poor vitality, possibly suffering from DED. It is also suppressed by the adjacent Lime.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
