Large eucalyptus tree at rear of garden. The very rear of garden falls within conservation area. Tree has doubled in height since purchase of house and is now overhanging garage and garden potentially posing a danger to buildings in next high winds.

Tree branches will be lopped by 2/3 metres to prevent any damage to buildings should they fall down in any high winds.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
