Apologies for delay in getting comments back in time.

Condition 5 -happy for this to be discharged.

Condition 10 - We see that there have been requests from other consultees for revisions and additional information for CTMP, so we'll hold fire with our comments until we see those, but it's largely acceptable in its current form.

Condition 20- we wouldn't recommend discharging until we've seen a detailed drawing. The applicants report states that they agree to the condition, but that's not sufficient for us to discharge. Once a detailed drawing is provided we'll also get in touch with highways design team in SMBC to get their comments on the temp access, and what they'd want to see for reinstatement of footway afterwards.
