Please describe the proposed works

We want to add a large brick porch to the front of our house which will be used to house a cloakroom and a downstairs toilet. The porch will be brick with no windows. It will have a composite door on the front in the centre and a open gable roof. The porch will measure 3 metres wide by 2 metres deep and will be 3 metres high at the highest point of the roof. It will be 1.9 metres away from the left hand side boundary fence and well over 2 metres from both the front boundary wall of the property and the right hand boundary. When looking at the porch from the front the front door will be central. To the left will be a separated room housing a toilet and a small sink and to the right will be an open space where cupboards will be built to house shoes and coats. The floor will be fully concrete and the roof will be tiled. The work will be completed by professionals and in line with building regulations.
