Works - a. Shorten primary limb on building to North East by 10ft approx. where the suckers are growing from.

- b. Remove any rubbing branches likely to fail.
- c. Thin the crown by 20% of the foliage by removing internal branches to allow greater air and light to pass through.
- d. Raise canopy to balance at approx. 4m.

Reason - Prevent damage to the adjacent building. Allow more light to neighbouring properties. Maintain low canopy to allow light under the tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
