The principle to erect 18 solar panels on the land specified would appear to require planning permission due to the fact that the panels appear to be on land outside of a residential garden.

If the applicant wished to erect the solar panels on land which was within their residential curtilage, then this would potentially not require planning permission subject to compliance with the General Permitted Development Regulations 2015 (as amended) Although more detail would be required in this event.

If the applicant did wish to erect solar panels on the land identified then should a full planning permission be submitted then the proposal may be likely to gain permission subject to the considerations of neighbouring amenity in terms of glare, battery storage and noise along with landscape and visual impacts. However, without more detail, which would be required to submit a planning application, it would be difficult to understand the implications of solar panels on this area of land.
