Yew (G1) - Two yew trees creating one uniform ball located next to the house. Fell to ground level the trees are blocking out large amounts of light to the house as well as beginning to encroach on the building (within 2.5m)
Will be replanted with 2 native species at 1.5m in height within the grounds of the garden

 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
