Trees are falling down due to the dry weather. Already had large branches break off. Immediate work to another tree required Apple tree to be cut down to a manageable level to ensure no damage will happen to property or persons

Cut down to a manageable level of 6 feet. Tree was subject to previous planning consent due to branches over the path. Tree is an old apple tree in the front garden.
