Identification of Tree(s) and Description of Works

x3 Ash trees along road side boundary of the residents property.

Working from the ash nearest the property first (ash nearest gates and nearest to property) - Ash 1 to be removed by sectional felling due to close proximity to house and significant lean towards property. Main reason for felling is due to evidence of carpenter ants at the base of the tree (lots of wood shavings as a result) suggesting considerable decay at the base of the tree and therefore severe structural weakness paired with the significant lean we deem this high risk to come down in strong winds most likely striking the residents property if it were to fall.

Ash 2 To crown clean (remove all major dead wood). Additionally to remove lowest lateral in close proximity to outbuilding roof, back to suitable points of regrowth or target pruned to collar. In this case the latter applies as no other suitable point of regrowth are applicable.

Ash 3 - To crown clean (remove all major dead wood). Further to this, remove any storm damage hangers or stubs within the canopy.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
