Installation of a tennis court on the current grass area, the current area is laid to grass, the proposed development will consist of a 150mm free draining stone base, with a 40mm compacted binder course, open graded ash felt and 25mm open graded porous ash felt with 18mm multi use tennis carpet. Concrete pre cast kerb edgings for the perimeter with a V-mesh fence surround 2m high at each end dropping down to 1.5m at either side. The court perimeter will be screened with an evergreen hedge all the way around, excluding entrance to the court. The lawn area is currently screened by a large hedge to the front (Hoveringham Road) and either sides of the property
