# Identification of Tree(s) and Description of Works

T1 Cherry - to fell, the cherry is beginning to push down the old boundary wall to the neighbouring paddock. It currently grows out of the drive way close to the house. Picture to be added to documents to show the wall being pushed over.

T2 & T3 - Labernums - to fell, these trees are both in poor canopy health with extensive dead wood and are growing into the boundary wall. More importantly these trees are growing into the canopy of the large lime tree.

T4 - Labernum - to fell, this tree has collapsed into the wall towards/ over the highway due to the extensive weight of ivy that has taken over it.

T5 - Cyprus - to fell, growing at chest height in the wall corner it has started to damage the wall leading onto the foot path and highway, it is also blocking the access for amnesty's such as oil van from being able to access the property to fill up on fuel.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
