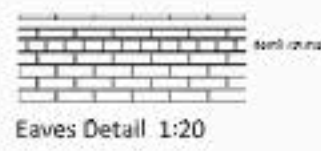

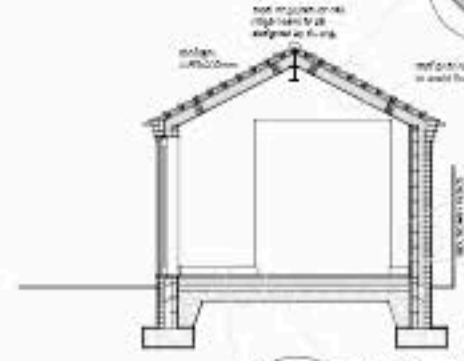

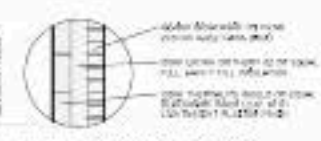

ROOF CONSTRUCTION (A) DETAIL 1:20



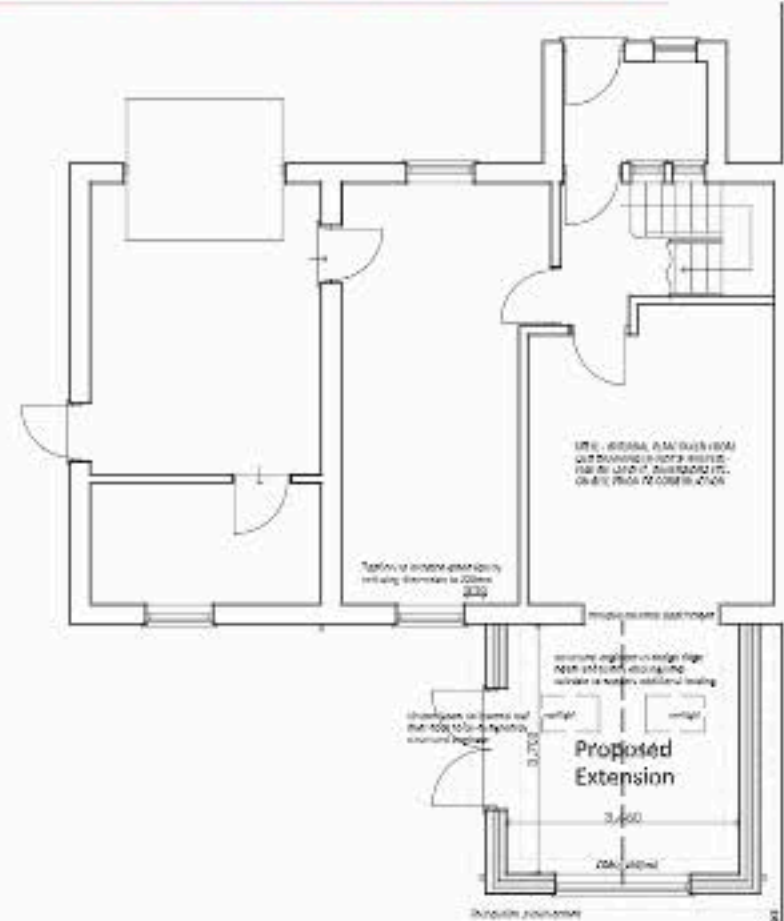
WALL CONSTRUCTION (B) DETAIL 1:20
