The tree (T1) is located in the woodland around the chalk pit in Upend. The ash tree is immediately opposite Ash Tree Cottage and the branch in question is leaning over the road and touching the ash tree immediately outside the pedestrian gate of Ash Tree Cottage. The branch is quite large and if it were to fall could be very dangerous as it is directly over the road. I propose cutting the branch back to the inside of the telephone wire. I have discussed this with a tree surgeon.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
