### Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

IMPORTANT - USE THE SITE MAP AS A REFERENCE TO TREE LOCATION AS IT WAS NOT LISTED UNDER POSTCODE T1 - Large multi-stem eucalyptus - reduce stem of garden (LHS when viewed from the garden) down to union point at approx 20ft to remove weight and leverage.

T2 - Crown raise chestnut to approx 15ft, maximum cut diameter 2"

T3 - On the inside (away from the road) top of the crown, there is a large vertical stem which had one stem tear out from a union and leave a large wound which has compromised the safety of the timber above it, this will be cut to below the wound site, to the best available pruning point

T4 - Removal of large low limb growing right over road and phone line

T5 and 6 - Two chestnuts which were previously felled but now have considerable regrowth. Fell to low stumps again.

Crown raise entire run of chestnut and beech to 4.2m roadside to prevent obstruction of vehicles and associated damage to trees.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - $\circ\;$  marking all trees on the plan, but only numbering those to which you want to carry out work
  - $\circ~$  showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
