Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

One conifer tree which is either a Thuja or Cupressus and is at the North Lane end of the property on the west side of the rear gates. There are sheds to the east and north of the tree. The lower branches extend three metres or so over the boundary with 29 Castle Street. The plan is to clear fell the tree and remove the debris from the site. As there is a Sycamore tree to the east of this tree and a mature apple tree to the immediate south and further trees and large shrubs in the garden there is no wish to plant another tree at present.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
