T1 Beech - prune back to where suitable from roadside to maintain clear walkway and vision to traffic approximately 1m

T2 plumb - prune back to where suitable from roadside to maintain clear walkway and vision to traffic approximately 0.75m

T3 cherry - even canopy on garden side approximately 1m

T4 cotoneaster - prune back into shape approximately 0.75m

T5 Magnolia - prune back from car port entrance approximately 0.75m

T6 ash - crown lift 3m & give 2m clearance from building

T7 cherry - crown lift 3m

T8 monkey puzzle - remove growth shoot as mostly dead and lower dead growth to approximately 2.5m

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
