T13 - Multi-stemmed Sycamore - Remove due to very poor condition and possible fungal infection. On a site visit on 18/10/22 due to concerns about the trees safety after a branch had fallen onto school road we found the tree to be in very poor condition. One stem was cracked at the base which we were very concerned about and after a phone call to NNDC it was agreed verbally that we could remove this stem on the day. We would now like to remove the rest of the tree leaving a stem at approx 2m high as a wildlife habitat and to support the bank.
