The work to be carried out is shown within the Report and Recommendations from North Country Tree Surgeons (which is included within the appendices), which is supported by a site layout and tree ID sketch. The recommendations are shown below:

Tree ID - Tree Type - Description - Recommendation

T2 - Ash - No visible signs of ash dieback as yet but will likely succumb - Monitor

T3 - Ash - No visible signs of ash dieback as yet but will likely succumb - Monitor

T16 - Ash - Some signs of ash dieback. (20% of tree) - Fell

T17 - Ash - Significant signs of ash dieback.- Fell

T22 - Ash - Significant signs of ash dieback.- Fell

T1 - Norway Maple - Very dense crown, outgrowing its space - 30% Crown reduction, 20% thin

T4 - Norway Maple - Very dense crown, outgrowing its space - 30% Crown reduction, 20% thin

T5 - Beach - Very one sided, outgrowing its space Pronounced lean - 30% Crown reduction, 20% thin

T12 - Norway Maple - Good health, needs reshaping - Crown reduction 25%, thin 10%

T21 - Norway Maple - Good health, needs reshaping - Crown reduction 25%, thin 10%

T22 - Norway Maple - Very dense crown - 25% crown thin

Storm Arwen hit the North East of England in November 2021. Since this event the trees in the preservation area (adjacent to 2 Norham Drive and 1 Whinham Way) are creaking and groaning, when further high winds have occurred. This is new and was never present prior to Storm Arwen.

Storm damage to the trees, prior to November 2021, has already been witnessed (attachment 4 - Photo 1), it was fortunate that no damage to the property occurred.

We (the owners of 2 Norham Drive), have also been approached by their neighbour at 1 Whinham Way, with regards to height of the trees in the TPO area, and the proximity to their property. They also have major concerns, as are outlined in this application.

I would like to refer to appendices, which clearly shows the density of the trees adjacent to 2 Norham Drive and 1 Whinham Way, and also shows the density of trees within the whole area covered by the TPO. The density adjacent to 2 Norham Drive is greater, and the proximity to property is closer.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
