Tree surgeon carried out under Easement works. Resident would like tree removed. If not permitted could we cut back more to improve light & reduce pest activity

There is a second oak next to the one resident would like removed which is further from the building.

Both trees were surveyed in June 2021. One, was recommended for crown lifting & removal of ivy on main stem & the other showed no defects.

As stated, resident would like one of them removed.

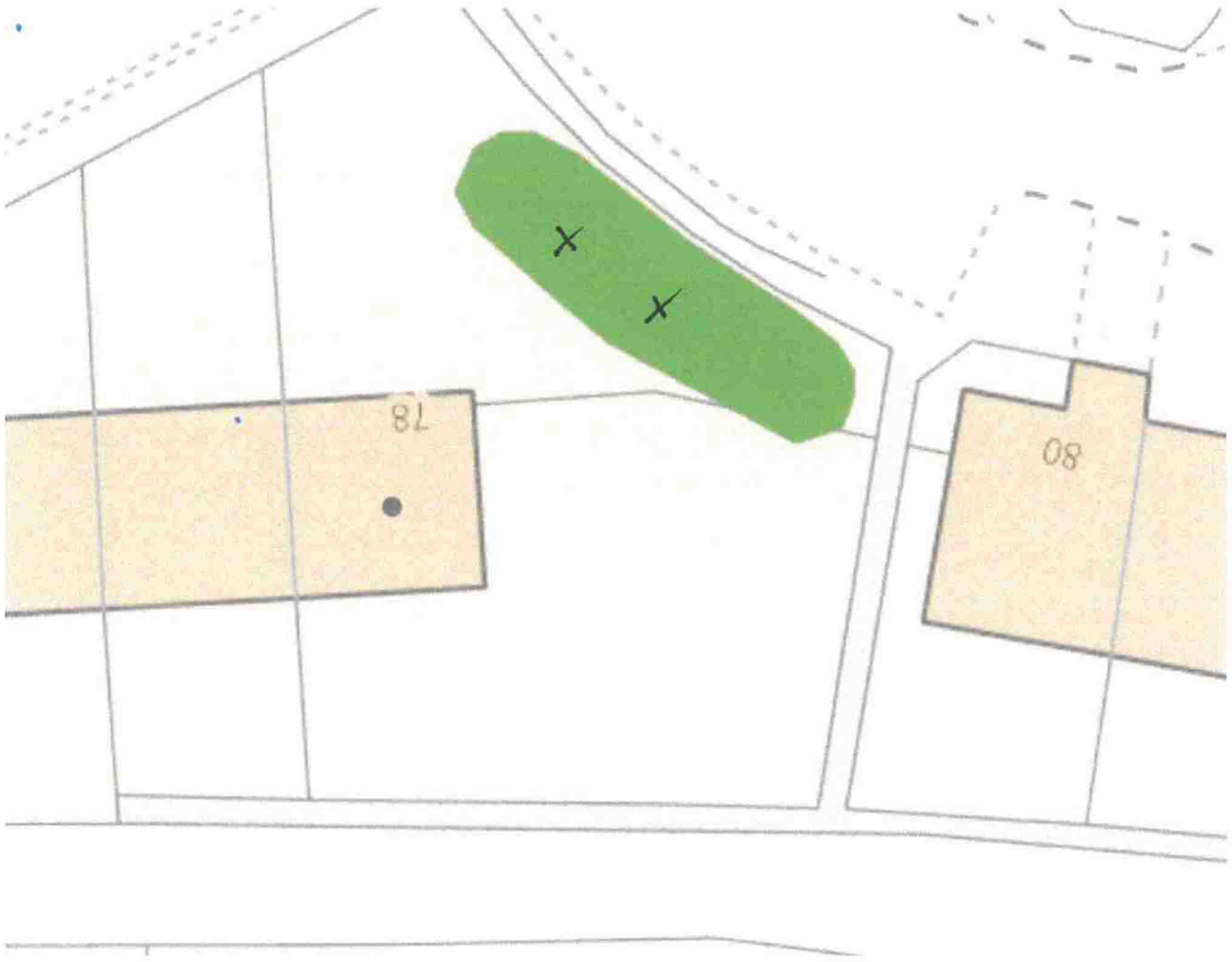
