1. REMOVE YEW TREE ADJOINING SCHOOL – when we advised TDC last year that this yew was dying we were advised to wait longer to be sure. The tree is now half bare, and the two tree surgeons from whom we sought advice & quotes confirm it is dead. We understand that removing the tree needs reporting to you.

## 7. Identification Of Tree(s) And Description Of Works continued ...

**1. MONTEREY CYPRESS** – The top of the trunk has a split (see photo at end – split is >1m. long); and branches are damaged from gales earlier in the year, some dangling over graveyard and path to football field. This happens every time we get a gale, each time costing money to get the tree made safe. We wish to employ a tree surgeon to:

- a. identify and remove any split, dead, and hanging limbs
- b. reduce crown by up to 30%, cutting back to growth points and balancing the whole. The aim is to reduce the incidence of branches splitting.
