T1 - Beech Tree

T2 - Bay Tree

The beech tree (T1) sits directly on the boundary line and the trunk and roots are now causing out patio stones to lift and it is now not level. The branches significantly overhang our property (shed and main house) and the leaves that fall block our gutters and drain pipes and we regularly have to have them cleaned. The damage to our patio makes it dangerous. I can only imagine the damage to our neighbour's garage/gutters and drive must be similar. We had tolerated this for some time, but now the patio has lifted we would like the beech tree to be removed. It is far too close to the boundary line and buildings that physical damage is now occurring. In a bad storm it could also fall onto our property causing further damage.

The bay tree (T2) again lies on our boundary and overhangs our property. The leaves contribute to the gutters blocking and as it is growing very fast it will soon be a risk to falling on to the house in a storm. We would like this tree trimming back significantly so we no longer have issues with it overhanging our land. We would like permission to prune the Bay tree so its crown lies 2.5m above ground level and reduce the spread leaving a 2m spread only by removing branches that overhang our property.

We are fully aware both trees lie on our neighbour's land (Denise Merryweather, The Croft, Embleton, NE66 3UW) . We have discussed this application with her and she is aware of what we have requested. We understand that we need the correct permissions to do this work as the properties are in a conservation zone.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
