Phase D1 - Commencing from 2021 Playing Field, Children's Play Area, Multi-Use Games Area (MUGA), Allotment Site, open space, remaining site wide S104 drainage ditches, swales, Detention Basins (DB1, DB2, DB4, DB5 & DB6) and plot earthworks to be phased in line with development parcels

Witham St Hugh's Phase 3 - Condition Discharge
