Details of the pre-application advice received

"The proposed design provides an uplift in scale to 193sqm with accommodation over two levels. I have checked the decision notice for the existing dwelling and it appears the permitted development rights are still intact. Having regard to the uplift that could theoretically be achieved through unspent permitted development rights, the scope of extensions previously approved (not built) and the scale in comparison to other permitted agricultural workers dwellings as highlighted in your case, it is my view that the proposed uplift in scale is likely to be supportable in principle.

The design of the dwelling is proposed as dormer style accommodation which is considered to be preferable to full two storey accommodation in this location. In my view the design and scale of the dwelling is generally acceptable in this location, particularly in terms of the high quality material palette outlined in the D & A statement".
