Holm Oak (T1) - reduce side of tree encroaching on Applicant's house by 2 metres due to proximity to the property and to improve light into the property.

Lime Tree (T2) - re-reduce tree back to previous growth points (approximate reduction of 3 metres) to improve light into the garden which is required due to Applicant's plans to landscape the garden with new plants.

Holm Oak (T3) - fell to ground level due to tree growing into T2. This will help the growth of T2. and re plant near by with a Betula Albosinensis

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
