Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Crown reduction of approx 1/3 to the Horse Chestnut tree located in the front garden which is approx 19 metres high (clinometric reading). Similar work to the tree was last carried out about 20 years ago and it has grown considerably in size since then. When in leaf and laden with conkers the branches are weighed down and hang heavily over Chapel Lane, causing a potential problem to traffic, and the effect on the front garden is that it is becoming increasingly shaded. The lower branches are also extremely close to the telephone line, as can be seen in one of the accompanying photos.

Two small cracks have appeared this year on the front wall of the house, which is approx 7 metres away from the base of the tree. These are inherently likely to have been caused by water being taken up by the roots of the chestnut tree during this year's exceptionally dry summer. Equally importantly, the tree has now attained a size and reach which make it a potential hazard to our house.

I have discussed the problem with Haydon Gibbons from Syston Tree Care who has done an excellent job of looking after and pruning our trees over the last 30+ years. He has checked the tree during his annual visits and done light pruning to keep the lower branches in check where they hang over the road to ensure that the tree is safe, whilst maintaining a good overall shape. He now feels that the time has come to do a crown reduction of the tree as requested above.

I have sent a sketch plan identifying the tree and its location, and also recent photographs of the tree to show the size and impact that it is having on it's surroundings, to externaldevelopmentcontrol@melton.gov.uk. I did try to attach them directly onto this application but somehow failed to succeed in doing so. Alex Coy kindly gave me the above address so I do hope that you will be able to locate them.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
