Our property boundary adjoins woodland with TPOs.

We recently applied for planning permission to fell/prune some overhanging oak trees adjoining our property (Ref: PP-11399579). This application was declined, however, the Arboricultural Officer, Rebekah Browning, advised that the application be amended with the following recommendations:

- o T1 Crown reduction of up to a maximum of 3 metres to suitable lateral branches
- o T2 Lateral reduction of damaged branch to a point distal to the rope damage, to suitable lateral branches
- o T3 Lateral reduction to suitable lateral branches or to branch collar as suited to ongoing management
- All work to be carried out in accordance with BS 3998:2010
- An advisory note should be appended to the decision notice regarding wildlife issues relating to disturbance to bats and birds
- Tree operations should be undertaken by a reputable, fully insured arborist: a list is provided on the council's website, under the tree management section, or contact the Arboricultural Association for contractors working within this area
- · Consent of the owner should be sought

We're now reapplying for planning permission, based on the recommendations made.
