Thanks for the prompt response, I have checked the measurements with our chosen tree surgeon and the details are as follows:

Tree T1 Tulip Tree - Current height 12.5m, would like to reduce by 2.5m, leaving tree at 10m
Tree T2 Lime - Current height 14.5m, would like to reduce by 2.5m, leaving tree at 10m Tree T4
Walnut - Current height 7m, would like to reduce by 1m, leaving tree at 6m Tree T5 Oak - Current
height 8m, would like to reduce by 1m, leaving tree at 7m Tree T6 Lime - Current height 9m, would
like to reduce by 2m, leaving tree at 7m

Hope this is satisfactory.
